- RULES:** MATCH GOVERNED BY CMP & MPRA RULES, NO ALIBIS ALLOWED. AMMO WILL **NOT** BE ISSUED. ALL SAFE AMMO, INCLUDING HANDLOADS, WILL BE ALLOWED. THE CLUB DOES HAVE *LIMITED* AMOUNTS OF GREEK HXP FOR SALE. TRIGGERS WILL BE WEIGHED AND RIFLES INSPECTED PRIOR TO MATCH.
- COURSE OF FIRE:** JOHN C. GARAND COURSE "A" USING STANDARD 200 YD. SR HIGHPOWER RIFLE TARGETS. **THERE WILL BE 3 MATCHES FOR A TOTAL OF 105 SHOTS.**
- RIFLES:** THIS WILL BE AN AS-ISSUED MATCH. RIFLES MUST CONFORM TO CMP RULES 4.1, 4.1.1, 4.1.2, 4.1.3, 4.1.4, & 4.1.6.
- ENTRY FEE:** \$40.00 ADULT, JUNIORS \$20.00 & POST ENTRIES ARE \$45.00
MRPA MEMBERS RECEIVE A \$5.00 DISCOUNT.
- REGISTRATION:** **REGISTRATION IS LIMITED TO THE FIRST 66 SHOOTERS. PRE-REGISTRATION IS REQUIRED. ENTRIES CLOSE AUGUST 28TH.
