- TIME:** REGISTRATION STARTS 8:00AM. FIRING STARTS AT 9:00AM.

- ELIGIBILITY:** ANYONE AGED 12 AND UP. AGES 12-17 MUST BE ACCOMPANIED BY A PARENT OR LEGAL GUARDIAN. EVERYONE MUST SIGN THE MPRC WAIVER OF LIABILITY. DO NOT NEED TO BE A MEMBER OF THE CLUB OR THE NRA. COST IS \$20.00 FOR ADULTS, JUNIORS AND DISABLED VETS \$10.00.
- RULES:** MATCH IS NOT GOVERNED BY THE NRA OR CMP. COACHING IS ALLOWED. PARTICIPANTS MAY ONLY SHOOT ONE RIFLE. THERE ARE NO ALIBIS, PARTICIPANTS WILL NEED TO SAFELY CLEAR ANY JAMS OR ISSUES WITH THE RIFLE IN THE TIME ALLOTTED. EYE AND EAR PROTECTION IS REQUIRED. SLINGS ARE ALLOWED EXCEPT IN STANDING.
- RIFLES & EQUIP:** AR-15's ONLY. THE RIFLE MAY HAVE EITHER METALLIC SIGHTS OR "ANY SIGHTS" WHICH INCLUDES SCOPES, ACOG's, ETC. RIFLES MAY HAVE A FIXED OR ADJUSTABLE STOCK. ANY BARREL LENGTH UP TO 26" AND ANY CALIBER INCLUDING AR-10's IN .308 ARE ALLOWED. SHOOTERS WILL NEED AT LEAST 2 MAGAZINES AND 60 ROUNDS OF AMMUNITION. AMMO IS NOT AVAILABLE AT THE RANGE. PLEASE BRING YOUR OWN SAFE AMMO.
- COURSE OF FIRE:** ALL FIRING SHOT AT 200 YARDS ON THE STANDARD SR HP TARGET. ALL STAGES WILL HAVE A 3 MIN. PREP PERIOD BEFORE FIRING BEGINS.
- STAGE 1:** 5 SIGHTERS AND 10 RECORD SHOTS IN 15 MINUTES SLOW FIRE PRONE.
- STAGE 2:** 10 SHOTS TIMED FIRE STANDING IN 2 MINUTES.
- STAGE 3:** 10 SHOTS RAPID FIRE FROM STANDING TO SITTING IN 60 SECONDS WITH A MAGAZINE CHANGE. (PERSONS WITH DISABILITIES AND THOSE AGED 60 AND OVER MAY START IN POSITION.
- STAGE 4:** 2-10 SHOT STRINGS RAPID FIRE FROM STANDING TO PRONE WITH A MAG. CHANGE IN 60 SECONDS.
- ADDITIONAL:** SHOOTERS ARE ENCOURAGED TO BRING A SPOTTING SCOPE OR BINOCULARS TO SCORE. FOOD AND WATER ARE NOT AVAILABLE AT THE RANGE, PLEASE BRING YOU OWN.
